Intended Use

For In Vitro Diagnostic Use. This antibody is designed for the specific localization of CD105 in formalin-fixed, paraffinembedded (FFPE) tissue sections. Evaluation must be performed by a qualified pathologist.

Summary and Explanation

CD105 (Endoglin) is a type 1 integral membrane protein with a large extracellular matrix. There are two alternatively spliced forms of Endoglin, S-Endoglin and L-Endoglin. Endoglin acts as an auxiliary receptor for the TGF-beta family of protein. These proteins have various roles in different physiological processes such as cellular proliferation and angiogenesis. Endoglin is expressed at low levels in endothelial cells, but highly expressed in vascular endothelial cells at sites of active angiogenesis such as tumor vessels, inflamed tissues, healing wounds, psoriatic skin, inflamed synovial arthritis, vascular injuries and during embryogenesis. With insufficient supply of blood, tumor cells will undergo apoptosis/necrosis.

Storage and Handling

Store at 2-8°C. Fresh dilutions, if required, should be prepared prior to use and are stable and steady for up to one day at room temperature (20-26°C). Diluted antibody preparations can be refrigerated or frozen for extended shelf life.

Principles of the Procedure

Antigen detection by immunohistochemistry (IHC) is a two-step process wherein the primary antibody binds to the antigen of interest and that binding is detected by a chromogen. The primary antibody may be used in IHC using manual techniques or BioGenex Automated Staining System. Positive and negative controls should always be run simultaneously with all patient specimens.

Reagents Provided

Mouse Monoclonal Antibody to CD105 protein antigen is affinity purified and diluted in PBS, pH 7.2, containing 1% BSA and 0.09% sodium azide.

Dilution of Primary Antibody

BioGenex Ready-to-Use antibodies have been optimized for use with the recommended BioGenex Detection System and should not require further dilution.

BioGenex concentrated antibodies must be diluted in accordance with the recommended protocol when used with the recommended BioGenex Detection System.

Limitations of the Procedure

Improper tissue handling and processing prior to immunostaining can lead to inconsistent results. Variations in embedding and fixation or the nature of the tissue may lead to variations in results. Endogenous peroxidase activity or pseudo peroxidase activity in erythrocytes and tissue biotin may result in non-specific staining based on the detection system employed. Tissues containing Hepatitis B Surface Antigen (HBsAg) may give false positive with horseradish peroxidase systems. Improper counterstaining and mounting may compromise the interpretation of results.
